POST-GRADUATE DIPLOMA IN LEGISLATIVE DRAFTING

Target Group

Entry Requirements

Prospective candidates must:

- (1) Have a Law degree from any recognised university; and
- (2) Be admitted to practice law in their respective countries for a minimum period of one year
